The QAD Technical Working Group (TWG) shall be at the venue on March 26, 2025 (Day 0) for logistics preparation.

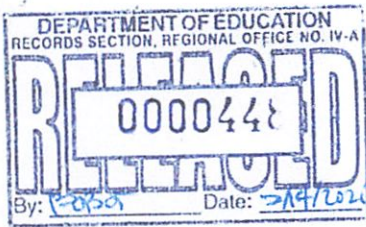
