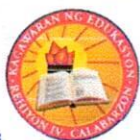
**CONDUCT OF THE NATIONAL SCREENING AND
ACCREDITATION OF ATHELETES FOR THE
2025 PALARONG PAMBANSA**

To: **Schools Division Superintendents**

1. In reference to DepEd Memorandum No. 021, S . 2024¹ and Regional Memorandum No. 85, s. 2025² through the Regional Screening and Accreditation Committee (RSAC) will conduct the National Screening and Accreditation of athletes for the 2025 Palarong Pambansa to ensure compliance with the established protocols and to undergo a thorough and diligent review process of the documentary requirements for the aforementioned event on March 31 – April 4, 2025 to be held at the Claro M. Recto Events Center, Lipa City.
2. The National Screening and Accreditation Committee (NSAC) shall interview, evaluate and verify the authenticity of the documents of athletes, coaches, assistant coaches and chaperones submitted by the head of the delegation for the Palarong Pambansa.
3. The list of athletes, coaches, assistant coaches and chaperones, and their respective screening and accreditation schedules for this activity will be issued on a separate issuance.

5. Travel and other related expenses relative to the conduct of this activity will be charged against the regional funds, while the SDO, shall be charged against their local funds, subject to the usual accounting and auditing rules and regulations.
