BAC RESOLUTION

RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO PINK PARSLEY CATERING SERVICES FOR THE PROCUREMENT OF CATERING SERVICES FOR THE CAPACITY BUILDING ON WRITING A RESEARCH

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES** for the **CAPACITY BUILDING ON WRITING A RESEARCH** on **MAY 5, 2025**;

WHEREAS, the Approved Budget for the Contract (ABC) is **NINE THOUSAND SIX HUNDRED PESOS (Php9,600.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the office website and conspicuous bulletin board in the premises of this Office from March 26, 2025 to March 31, 2025 at 9:00 a.m.;

WHEREAS, RFQs were likewise sent to four (4) prospective suppliers as follows: (1) God's Treasure Enterprises; (2) Pink Parsley Catering Services; (3) Focal Managing Loop Inc.; and (4) DepEd Region IV-A CALABRAZON Multipurpose Cooperative;

WHEREAS, one (1) Supplier submitted its proposal, **PINK PARSLEY CATERING SERVICES** in the amount of **NINE THOUSAND TWO HUNDRED PESOS (Php9,200.00)**. Thus, **PINK PARSLEY CATERING SERVICES** is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposals, **PINK PARSLEY CATERING SERVICES** complied with the requirements and is hereby declared as the Single Calculated and Responsive Quotation (SCRQ);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **PINK PARSLEY CATERING SERVICES** in the amount of **NINE THOUSAND TWO HUNDRED PESOS (Php9,200.00)**.
