**RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF
CONTRACT TO GRAND MONACO PREMIER HOTEL INC. (MONACO HOTEL)
FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE
STRENGTHENING THE SCHOOL-BASED FEEDING PROGRAM (SBFP):
CAPACITY BUILDING ON NUTRITION ASSESSMENT AND ANTHROPOMETRIC
MEASUREMENT**

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **STRENGTHENING THE SCHOOL-BASED FEEDING PROGRAM (SBFP): CAPACITY BUILDING ON NUTRITION ASSESSMENT AND ANTHROPOMETRIC MEASUREMENT** on **MAY 6-8, 2025**;

WHEREAS, the Approved Budget for the Contract (ABC) is **THREE HUNDRED FORTY-FOUR THOUSAND FOUR HUNDRED PESOS (Php344,400.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) on March 27, 2025, in the office website and conspicuous bulletin board in the premises of this Office starting on March 26, 2025 to March 31, 2025 at 9:00 a.m.;

WHEREAS, RFQs were likewise sent to at least three (3) prospective suppliers as follows: (1) Grand Monaco Premier Hotel; (2) Ciudad Christhia Resort 9 Waves; and (3) Timberland Highland Resort;

WHEREAS, one (1) Supplier submitted its proposal, **GRAND MONACO PREMIER HOTEL INC. (MONACO HOTEL)** in the amount of **THREE HUNDRED FORTY-THREE THOUSAND FIVE HUNDRED SEVENTY-FIVE PESOS (Php343,575.00)**. Thus, **GRAND MONACO PREMIER HOTEL INC. (MONACO HOTEL)** is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, **GRAND MONACO PREMIER HOTEL INC. (MONACO HOTEL)** complied with the requirements and is hereby declared as the Single Calculated and Responsive Quotation (SCRQ);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **GRAND MONACO PREMIER HOTEL INC. (MONACO HOTEL)**


