WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of CATERING SERVICES for the QUARTERLY PROGRAM IMPLEMENTATION REVIEW (PRE-PIR) WORKSHOP on APRIL 10-11, 2025, JULY 17-18, 2025, OCTOBER 9-10, 2025 and DECEMBER 15-16, 2025;

WHEREAS, the Approved Budget for the Contract (ABC) is ONE HUNDRED FIVE THOUSAND SIX HUNDRED PESOS (Php105,600.00):

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System on March 11, 2025, in the office website and conspicuous bulletin board in the premises of this Office from March 10, 2025 to March 14, 2025 at 9:00 a.m.;

WHEREAS, RFQs were likewise sent to four (4) prospective suppliers as follows: (1) Pink Parsley Catering Services; (2) Focal Managing Loop Inc.; (3) God's Treasure Enterprises; and (4 DepEd Region IV-A CALABRAZON Multipurpose Cooperative);

WHEREAS, two (2) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:
