WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **CONSULTATIVE CONFERENCE ON THE IMPLEMENTING GUIDELINES AND PROGRAM IMPLEMENTATION EVALUATION TOOLS FOR PAGKILALANG HIRAYA** on **MARCH 24-28, 2025**;

WHEREAS, the Approved Budget for the Contract (ABC) is **THREE HUNDRED SIXTY-TWO THOUSAND PESOS (Php362,000.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System on March 11, 2025, in the office website and conspicuous bulletin board in the premises of this Office from March 10, 2025 to March 14, 2025 at 9:00 a.m.;

WHEREAS, RFQs were likewise sent to at least three (3) prospective suppliers as follows: (1) M.I. Sevilla Resort; (2) Queen Margarette Hotel Inc.; and (3) Sioland Grand Premier Hotel;

WHEREAS, two (2) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:


