WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of CATERING SERVICES for the SEMI-ANNUAL MEETING KMT PROCESS REVIEW on MARCH 26, 2025 and NOVEMBER 21, 2025;

WHEREAS, the Approved Budget for the Contract (ABC) is THIRTY-TWO THOUSAND FOUR HUNDRED PESOS (Php32,400.00);

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the office website and conspicuous bulletin board in the premises of this Office from March 11, 2025 to March 17, 2025 at 9:00 a.m.;

WHEREAS, RFQs were likewise sent to four (4) prospective suppliers as follows: (1) Pink Parsley Catering Services; (2) God's Treasure Enterprises; (3) Focal Managing Loop Inc.; and (4 DepEd Region IV-A CALABRAZON Multipurpose Cooperative);

WHEREAS, two (2) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:
