WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES** for the **CONSULTATIVE MEETING WITH THE SELECT REGIONAL AGENCIES ON THE MECHANISM ON TRACKING OF BASIC EDUCATION DATA** on **APRIL 15, 2025**;

WHEREAS, the Approved Budget for the Contract (ABC) is **NINE THOUSAND SIX HUNDRED PESOS (Php9,600.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the office website and conspicuous bulletin board in the premises of this Office from March 18, 2025 to March 24, 2025 at 9:00 a.m.;

Whereas, RFQs were sent to at least three (3) prospective suppliers as follows: (1) Pink Parsley Catering Services; (2) God's Treasure Enterprises; and (3) DepEd Region IV-A CALABARZON Multipurpose Cooperative;

WHEREAS, one (1) Supplier submitted its proposal, **PINK PARSLEY CATERING SERVICES** in the amount of **NINE THOUSAND TWO HUNDRED PESOS (Php9,200.00)**. Thus, **PINK PARSLEY CATERING SERVICES** is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposal, **PINK PARSLEY CATERING SERVICES** complied with the requirements and is hereby declared as the Single Calculated and Responsive Quotation (SCRQ);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **PINK PARSLEY CATERING SERVICES** in the amount of **NINE THOUSAND TWO HUNDRED PESOS (Php9,200.00)**
