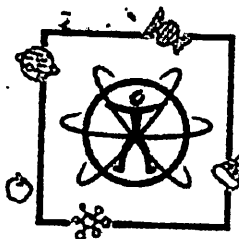

Greetings from the science clubbing movement!



### **2025 NATIONAL CHILDREN'S SCIENCE INTERACTIVE WORKSHOP**

The Philippine Society of Youth Science Clubs (PSYSC) Inc. will conduct the 2025 National Children's Science Interactive Workshop (CSIW) in Luzon on June 4-7, 2025.

The CSIW event will feature lectures and workshops focused on Earth Science to enhance learners' appreciation of this specific field of science. It aims to

1. discuss the impact of science technology and engineering (ST&E) on humanity through interaction with experts in the field;
2. promote interest and awareness among participants in ST&E, encouraging them to pursue further knowledge in these fields;
3. encourage the participants to pursue opportunities as players in the ST&E in the future;
4. provide a venue for exchanging ideas and promoting camaraderie among elementary science club members nationwide; and
5. encourage more students to join science clubs and engage actively in the science club movement.

The event is open to elementary students from Grades 4 to 6, teachers, science club advisers, and coaches nationwide.

Participation of learners and teachers from public and private schools shall be purely voluntary and will not hamper instructional time in compliance with the provisions of DepEd Order (DO) No. 009, s. 2024 titled Implementing Guidelines on the School Calendar and Activities for the School Year 2024-2025 and DO 9, s. 2005, titled Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith and the policy on off-campus activities stated in DO 66, s. 2017.
