To: Schools Division Superintendents of Bacoor City, General Trias City, Lipa City, Dasmariñas City Calamba City and Rizal Province

- 1. - 4. Travel and other related expenses relative to the conduct of this activity will be charged against the regional funds while the SDO shall be charged against their local funds, subject to the usual accounting and auditing rules and regulations.
