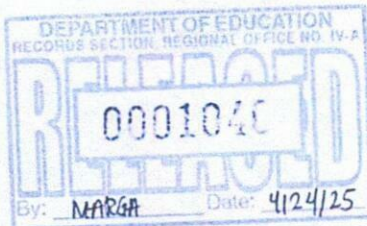


To: **Schools Division Superintendents of Bacoar City,

1. In reference to OM – OUOPS – 2025 - 01337<sup>1</sup>, this Office through the Regional Screening and Accreditation Committee will conduct an interview, evaluation and verification to the select Athletes, Coaches, Assistant Coaches and Chaperons for the 2025 Palarong Pambansa in line with the selection process of the aforementioned event, for those athletes who were **unable to attend during the original dates due to justifiable reasons**.
2. The athletes, coaches, assistant coaches, and chaperones are required to submit prescribed documentary requirements for the Palaro, valid documentation supporting their absence. Upon review and approval, they will be accommodated in a rescheduled session to ensure fairness and inclusivity in the selection process. 3. The Schools Division Office / District Office is hereby requested to prepare an appropriate venue for the conduct of the interview and screening of athletes, coaches, assistant coaches, and chaperones in line with the preparations for the 2025 Palarong Pambansa. Ensure that the venue is conducive to the said activity and equipped with the necessary facilities to support a smooth and orderly screening process.
4. Travel and other related expenses relative to the conduct of this activity will be charged against the regional funds while the SDO shall be charged against their local funds, subject to the usual accounting and auditing rules and regulations.
