DEPLOYMENT OF THE “ONE LOGISTICAL INTERFACE FOR NAVIGATING KEY PROGRESS (ONE LINK)”

1. In alignment with the **Basic Education Development Plan (BEDP) 2030** and the **Secretary’s 5-Point Agenda**, DepEd CALABARZON continues to prioritize the modernization of education management and the strengthening of governance through efficient, responsive, and continuously improving systems. The **Regional Education Development Plan (REDP)** highlights the vital role of information systems in promoting data-driven policy formulation, streamlined operations, and increased accountability—reinforcing the region’s commitment to innovation, transparency, and good governance.

In support of these priorities, this Office through the **Policy, Planning, and Research Division (PPRD)** deploys the **DepEd CALABARZON ONE LINK**, a centralized digital platform for accessing and monitoring the region’s key progress. The platform provides real-time updates on compliance with DepEd’s mandated data collection activities and also integrates **significant updates related to education planning, data management, research management, and policy review**, ensuring that schools, Schools Division Offices (SDOs), and the Regional Office remain aligned with DepEd’s reporting and governance standards.
