**RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO OUAN'S WORTH FARM AND FAMILY RESORT CORPORATION FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE CONDUCT OF THE ORIENTATION ON THE SUPPLEMENTAL AND EXPANDED GUIDELINES OF DEPED ORDER NO. 40, S. 2012 CUM IMPLEMENTATION OF SAFE SPACES ACT IN BASIC EDUCATION**

**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **CONDUCT OF THE ORIENTATION ON THE SUPPLEMENTAL AND EXPANDED GUIDELINES OF DEPED ORDER NO. 40, S. 2012 CUM IMPLEMENTATION OF SAFE SPACES ACT IN BASIC EDUCATION** on **MAY 14-16, 2025**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **SIX HUNDRED TWELVE THOUSAND PESOS (Php612,000.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) on April 25, 2025, in the office website and conspicuous bulletin board in the premises of this Office starting on April 24, 2025 to April 28, 2025 at 9:00 a.m;

**WHEREAS**, RFQs were likewise sent to four (4) prospective suppliers as follows: (1) Queen Margarette Hotel Inc.; (2) M.I. Sevilla resort; (3) Lucena Fresh Air Hotel and Resort; and (4) Ouan's Worth Farm and Family Resort Corporation;

**WHEREAS**, three (3) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:


