## **BAC RESOLUTION**

RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO COUNTRY BANKERS INSURANCE CORPORATION FOR THE PROCUREMENT OF TRAVEL INSURANCE FOR THE EDUCATION BOOTCAMP SERIES ON CAMPUS JOURNALISM – NATIONAL SCHOOLS PRESS CONFERENCE 2025

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of TRAVEL INSURANCE for the EDUCATION BOOTCAMP SERIES ON CAMPUS JOURNALISM – NATIONAL SCHOOLS PRESS CONFERENCE 2025 on MAY 18-24, 2025;

WHEREAS, the Approved Budget for the Contract (ABC) is THIRTY THOUSAND PESOS (Php30,000.00);

**WHEREAS,** Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS,** the Request for Quotation (RFQ) was posted in the office website and conspicuous bulletin board in the premises of this Office starting on April 30, 2025 to May 5, 2025 at 9:00 a.m;

**WHEREAS,** RFQs were likewise sent to at least three (3) prospective suppliers as follows: (1) AXA Philippines; (2) Country Bankers Insurance Corporation; and (3) Pru Life UK;

WHEREAS, one (1) Supplier submitted its proposal; COUNTRY BANKERS INSURANCE CORPORATION in the amount of THIRTY THOUSAND PESOS (Php30,000.00). Thus, COUNTRY BANKERS INSURANCE CORPORATION is declared as the lone bidder;

**WHEREAS**, after review and deliberation on the proposal, **COUNTRY BANKERS INSURANCE CORPORATION** complied with the requirements and is hereby declared as the Single Calculated and Responsive Quotation (SCRQ);

**NOW, THEREFORE**, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **COUNTRY BANKERS INSURANCE CORPORATION** in the amount of **THIRTY THOUSAND PESOS** (**Php30,000.00**).
