RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO DEPED REGION IV-A CALABARZON MULTIPURPOSE COOPERATIVE FOR THE PROCUREMENT OF CATERING SERVICES FOR THE EDUCATION ASSESSMENT AND RESEARCH - DEVELOPMENT VALIDATION OF PISA-LIKE ASSESSMENT TOOL FOR GRADE 5 AND GRADE 8 (PHASE 1) ON MAY 27, 2025

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES** for the **EDUCATION ASSESSMENT AND RESEARCH - DEVELOPMENT VALIDATION OF PISA-LIKE ASSESSMENT TOOL FOR GRADE 5 AND GRADE 8 (PHASE 1) ON MAY 27, 2025**;

WHEREAS, the Approved Budget for the Contract (ABC) is **TWENTY-SEVEN THOUSAND SIX HUNDRED PESOS (Php27,600.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the office website and conspicuous bulletin board in the premises of this Office from April 29, 2025 to May 5, 2025 at 9:00 a.m.;

WHEREAS, RFQs were likewise sent to at least four (4) prospective suppliers as follows: (1) Pink Parsley Catering Services; (2) God's Treasure Enterprises; (3) Focal Managing Loop Inc.; and (4) DepEd Region IV-A CALABRAZON Multipurpose Cooperative.

WHEREAS, one (1) supplier submitted its proposal; **DEPED REGION IV-A CALABRAZON MULTIPURPOSE COOPERATIVE** in the amount of **TWENTY-SIX THOUSAND NINE HUNDRED TEN PESOS (Php26,910.00)**. Thus, **DEPED REGION IV-A CALABRAZON MULTIPURPOSE COOPERATIVE** is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposals, **DEPED REGION IV-A CALABRAZON MULTIPURPOSE COOPERATIVE** complied with the requirements and is hereby declared as the Single Calculated and Responsive Quotation (SCRQ);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **DEPED REGION IV-A CALABRAZON MULTIPURPOSE**
