RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO GRAND MONACO PREMIER HOTEL INC. FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE EDUCATION BOOTCAMP SERIES

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of FOOD AND ACCOMMODATION for the EDUCATION BOOTCAMP SERIES on MAY 13-15, 2025;

WHEREAS, the Approved Budget for the Contract (ABC) is THREE HUNDRED NINETY-SIX THOUSAND PESOS (Php396,000.00);

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) on April 26, 2025, in the office website and conspicuous bulletin board in the premises of this Office starting on April 25, 2025 to April 29, 2025 at 9:00 a.m;

WHEREAS, RFQs were likewise sent to four (4) prospective suppliers as follows: (1) Grand Monaco Premier Hotel Inc.; (2) First Pacific Leadership Academy; (3) The First Villa Cristina Hotel & resort Inc.; and (4) Momarco Forest Cove resort and Hotel (Momarco Forest Cove);

WHEREAS, two (2) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:


