# REGIONAL CONVERGENCE IN THE IMPLEMENTATION OF SUPPORT TO SCHOOLS FOR IMPROVED LEARNING OUTCOMES (PHASE 1)

To: Schools Division Superintendents Regional PISA Monitoring Officials All Others Concerned

- In reference to DepEd Memorandum No. 001, s. 2025 on the Operational Guidelines on the Implementation of Support to Schools for Improved Learning Outcomes, and Unnumbered Memorandum dated February 28, 2025 titled Regional Convergence in the Implementation of Support to Schools for Improved Learning Outcomes, this office will conduct the Regional Convergence in the Implementation of Support to Schools for Improved Learning Outcomes (Phase 1) on June 5-6, 2025 at Development Academy of the Philippines (DAP), Tagaytay City.
