CONTRACT OF SERVICE

KNOW ALL MEN BY THESE PRESENTS:

This contract made and entered into by and between:

DEPARTMENT OF EDUCATION REGIONAL OFFICE IV-A CALABARZON, a component field office of the government entity known as the Department of Education organized under existing Philippine laws with office address at Gate 2, Karangalan Village, Cainta, Rizal and herein represented by its Regional Director, **ATTY. ALBERTO T. ESCOBARTE**. It shall be referred in this agreement as the **CLIENT**.

AZTECO CORPORATION (AXIAA HOTEL), a domestic corporation duly registered under the Philippine laws, with principal address at 135 West Ave., Barangay Bungad, Quezon City, represented herein by its Sales Director, **JENNY LUSUAN**, hereinafter referred to as the **HOTEL COMPANY**.

WITNESSETH

WHEREAS, the **CLIENT** needs the services of a hotel company who will provide food and conference hall to the participants in the **"INCENTIVE-BASED ACTIVITY FOR LEARNERS TO IMPROVE LEARNING OUTCOMES: (AWARDING OF PISA SCHOOLS IN RELATION TO PISA ACTIVITIES TOWARDS IMPROVED LEARNING OUTCOMES)"** on **JUNE 10, 2025** to be conducted by the Client.

WHEREAS, the Approved Budget for the Contract (ABC) is **THREE HUNDRED THIRTY-SEVEN THOUSAND FIVE HUNDRED PESOS (Php337,500.00)**.

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof.

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) on May 3, 2025, at the website of DepEd Region IV-A CALABARZON, and conspicuous bulletin board in the premises of DepEd Region IV-A CALABARZON on May 2, 2025 to May 7, 2025 at 9:00am.

WHEREAS, RFQs were likewise sent to four (4) prospective suppliers namely:

1. First Pacific Leadership Academy;
2. BGISTS Development Corporation;
3. Azteco Corporation (Axiaa Hotel); and
4. Grand Monaco Premier Hotel Inc.

WHEREAS, two (2) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:

WHEREAS, upon evaluation or careful examination of the technical specification submitted by **AZTECO CORPORATION (AXIAA HOTEL)**, the BAC found that it was compliant with the proposed amount of **THREE HUNDRED THIRTY-SEVEN THOUSAND FIVE HUNDRED PESOS (Php337,500.00)**.

WHEREAS, after review and deliberation on the proposals, **AZTECO CORPORATION (AXIAA HOTEL)** complied with the requirements and is hereby declared as the Single Calculated and Responsive Quotation (SCRQ).

WHEREAS, the Client invited bids for the Procurement for the hotel accommodation of the participants in the **“INCENTIVE-BASED ACTIVITY FOR LEARNERS TO IMPROVE LEARNING OUTCOMES: (AWARDING OF PISA SCHOOLS IN RELATION TO PISA ACTIVITIES TOWARDS IMPROVED LEARNING OUTCOMES”** on June 10, 2025 and has accepted the bid/quotation of the Hotel Company for food and conference hall in the sum of **THREE HUNDRED THIRTY-SEVEN THOUSAND FIVE HUNDRED PESOS (Php337,500.00)**. (Hereinafter called “the Contract Price”).

NOW, THEREFORE, for and in consideration of the foregoing premises of the mutual covenants and provisions hereafter set forth, the parties hereto have agreed and do hereby mutually agree as follows:

Section 1
Responsibilities of the Hotel Company

The **Hotel Company** shall:

1. Provide food and conference hall on June 10, 2025 to the participants, of the **Client**. The details and/or specifications of these services are provided under Section 4 of this contract.
2. Maintain that all of the services to be performed under or pursuant to this contract shall be of the standard and quality which prevail among similar businesses and organizations of superior knowledge and skill engaged in providing similar services under the same or similar circumstances.
3. Provided with personnel to:
 - 3.1 maintain cleanliness in the function hall, restrooms, sleeping quarters, hallway, pantry, and dining area;
 - 3.2 assist participants and guest with special conditions, breastfeeding moms, PWDs, and other emergency situation;
 - 3.3 respond to safety and security requirements of the government;
 - 3.5 appropriate and sufficient parking area for VIPs and guests; and
 - 3.6 with 24-hour security, front-desk and housekeeping services

4. Do such other acts which are necessary in the performance of the above functions as well as those obligations arising from this contract.

Section 2 Responsibilities of the Client

The **Client** shall:

1. Pay the **Hotel Company** the guaranteed number of participants
2. Charged or billed the total amount of **THREE HUNDRED THIRTY-SEVEN THOUSAND FIVE HUNDRED PESOS (Php337,500.00)** for the whole duration of the event.
3. Exercise strict discipline, close supervision and exclusive control and administration over its participants in accordance with law, ordinances and pertinent government rules and regulations as well as the rules and policies laid down by the **Hotel Company** on the matter;

Section 3 Terms of Payment

The **Client** binds itself to pay the **Hotel Company** within thirty (30) days after the conclusion of the training/seminar. The **Hotel Company** hereby understands that the focal person must be the one responsible for the immediate processing of payments.

Section 4 Specification of the services

The **Hotel Company** shall provide for the following:

- a. **The meals shall be:**
 - a.1 complete meal (breakfast, AM snacks, lunch and PM snacks) to the **225** participants of the Client.
 - a.2 served by any type of buffet with stand-by waiters during breakfast and lunch.
 - a.3 first meal is **breakfast**, and last meal is **PM snacks** on June 10, 2025.
 - a.4 with unlimited coffee, purified drinking water, tea or chocolate drink and candies, with assistance of stand-by waiters.
 - a.5 AM and PM Snacks with drinks, no soft drinks.
- b. **The Function Hall and Facilities shall be:**
 - b.1 frequently sanitized grand/spacious function hall with a Conference Set-up that can accommodate **225** pax.
 - b.2 providing 2 rooms for dressing rooms.
 - b.3 providing 1 room for Secretariat.
 - b.4 well-lighted and well ventilated.
 - b.5 with available audio-visual equipment with stand-by personnel to assist in the operation of:
 - b.5.1 one (1) LED screen.
 - b.5.2 complete set sound system.
 - b.5.3 four (4) microphones (2 wireless and 2 wired microphones) with two (2) microphone stands.
 - b.4.4 Podium/lectern.
 - b.6 Unlimited access to internet/Wi-Fi in all areas of venue.

- b.7** free tarpaulin at least 2 pcs – outside and main hall hanging – with DepEd logo and details of the training.
- b.8** no pillars in the middle of the function room.
- b.9** provision of at least three (3) tables for the Secretariat (Registration Area).

Section 5 **Use of Hotel Parking Space**

The **Hotel Company** shall allow the use of its parking space to the participants free of charge.

Section 6 **Termination of Contract**

Any party may terminate this Contract based on the grounds provided and after compliance with Annex "I" of the 2016 Implementing Rules and Regulations of Republic Act 9184.

Section 7 **Settlement of Dispute**

If any dispute of difference of any kind whatsoever shall arise between the parties in connection with the implementation of this contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.

Any and all dispute arising from the implementation of a contract shall be submitted to arbitration in the Philippines according to the provisions of R.A. 876, otherwise known as the "Arbitration Law" and R.A. 9285, otherwise known as the "Alternative Dispute Resolution Act of 2004." By mutual agreement, the parties agree in writing to resort to other alternative modes of dispute resolution.

Section 8 **Capacity and Authorization**

Each of the parties to this contract hereby represents and warrants to the other that it is duly authorized and empowered to execute, deliver and perform this contract and that such action does not conflict with or violate any provision of law, regulation, policy, contract, deed of trust or other instrument to which it is a party or by which it is bound and that this contract constitutes a valid and binding obligation between the parties.

Section 9 **Other conditions of the contract**

- a. In case of damage to the property of the participants of the **Client** caused by negligence of the personnel of the **Hotel Company**, the **Hotel Company** shall be liable for the damages;
- b. Necessary medical services and facilities shall be the responsibility and for the account of the **Hotel Company**; and
- c. The **Hotel Company** shall cause the notarization of this contract.
