d. Provide an opportunity for the participants to interact with the officials and ask questions.

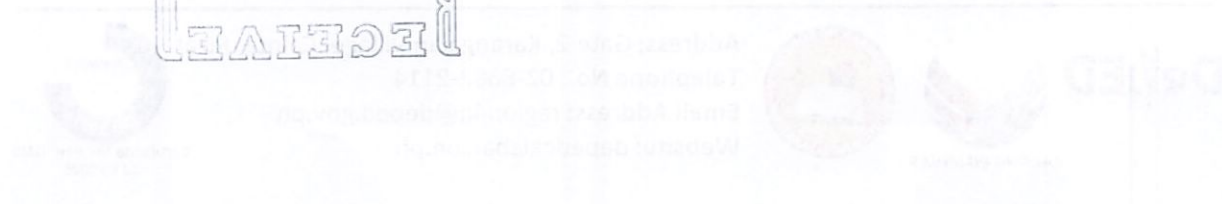


