RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO NOVOTEL (HOTEL) CORP./EUROTEL HOTEL - MAKATI FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE R4A CALABARZON REGIONAL CAPACITY BUILDING OF MADRASAH EDUCATION PROGRAM (MEP) IMPLEMENTERS FOR SCHOOL LEADERS ON AUGUST 27-29. 2025

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of FOOD AND ACCOMMODATION for the R4A CALABARZON REGIONAL CAPACITY BUILDING OF MADRASAH **EDUCATION PROGRAM** IMPLEMENTERS FOR SCHOOL LEADERS ON AUGUST 27-29, 2025;

WHEREAS, the Approved Budget for the Contract (ABC) is THREE HUNDRED THOUSAND PESOS (Php300,000.0);

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof:

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) on June 3, 2025, at the office website and conspicuous bulletin board in the premises of this Office from June 2, 2025 to June 9, 2025 at 9:00 a.m.;

WHEREAS, RFOs were likewise sent to at least three (3) prospective suppliers as follows: (1) Novotel (Hotel) Corp./Eurotel Hotel - Makati; (2) Berjaya Makati Hotel Philippines; and (3) City Garden Grand Hotel.

WHEREAS, two (2) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:
