## **BAC RESOLUTION**

RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO SUNRISE RIDGE CORPORATION (SOLESTE SUITES) FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE CAPACITY BUILDING ON UPLOADING OF THE COMPLETED RESEARCH PAPER IN THE E-SALIKSIK PORTAL ON AUGUST 11-13, 2025

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of FOOD AND ACCOMMODATION for the CAPACITY BUILDING UPLOADING OF THE COMPLETED RESEARCH PAPER IN THE E-SALIKSIK PORTAL ON AUGUST 11-13, 2025;

WHEREAS, the Approved Budget for the Contract (ABC) is ONE HUNDRED EIGHTY THOUSAND PESOS (Php180,000.00;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof:

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) on June 3, 2025, at the office website and conspicuous bulletin board in the premises of this Office from June 2, 2025 to June 9, 2025 at 9:00 a.m.;

WHEREAS, RFQs were likewise sent to at least three (3) prospective suppliers as follows: (1) Sunrise Ridge Corporation (Soleste Suites); (2) Red Hotel; and (3) Madison 101 Hotel.

**WHEREAS**, one (1) supplier submitted its proposal; SUNRISE RIDGE CORPORATION (SOLESTE SUITES) in the amount of ONE HUNDRED SEVENTY-ONE THOUSAND **PESOS** (Php171,000.00). Thus, SUNRISE **CORPORATION (SOLESTE SUITES)** is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposals, SUNRISE RIDGE CORPORATION (SOLESTE SUITES) complied with the requirements and is hereby declared as the Single Calculated and Responsive Quotation (SCRQ);

NOW, THEREFORE, the BAC hereby RESOLVES as it hereby RESOLVED to RECOMMEND to the Regional Director, as the Head of the Procuring Entity, the award of the project to SUNRISE RIDGE CORPORATION (SOLESTE SUITES) in the amount of ONE HUNDRED SEVENTY-ONE THOUSAND PESOS (Php171,000.00).


