RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO SUNRISE RIDGE CORPORATION (SOLESTE SUITES) FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE CAPACITY BUILDING ON THE FORMULATION OF MONITORING & EVALUATION (M&E) AND IMPLEMENTATION PLANS FOR RESEARCH MANAGEMENT ON JULY 10-11, 2025

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of FOOD AND ACCOMMODATION for the CAPACITY BUILDING ON THE FORMULATION OF MONITORING & EVALUATION (M&E) AND IMPLEMENTATION PLANS FOR RESEARCH MANAGEMENT ON JULY 10-11, 2025;

WHEREAS, the Approved Budget for the Contract (ABC) is ONE HUNDRED TWENTY THOUSAND PESOS (Php 120,000.00);

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) on June 18, 2025, at the office website and conspicuous bulletin board in the premises of this Office from June 17, 2025 to June 23, 2025 at 9:00 a.m.;

WHEREAS, RFQs were likewise sent to at least six (6) prospective suppliers as follows: (1) Sunrise Ridge Corporation (Soleste Suites); (2) Madison 101 Hotel; (3) Azteco Corporation (Axiaa Hotel); (4) Red Hotel, Inc.; (5) Great Eastern Hotel, Inc. and (6) Sequoia Hotel - Quezon City;

WHEREAS, two (2) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:


