## BAC RESOLUTION

**RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO DEPED REGION IV-A CALABARZON MULTIPURPOSE COOPERATIVE FOR THE PROCUREMENT OF CATERING SERVICES FOR THE REGIONAL OFFICE-SCHOOLS DIVISION OFFICE REGIONAL LEGAL EXECUTIVE COORDINATION MEETING (ReLEXECOM) - 1<sup>ST</sup> HALF ON JULY 16, 2025**

**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES** for the **REGIONAL OFFICE-SCHOOLS DIVISION OFFICE REGIONAL LEGAL EXECUTIVE COORDINATION MEETING (ReLEXECOM) - 1<sup>ST</sup> HALF ON JULY 16, 2025**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **NINETEEN THOUSAND TWO HUNDRED PESOS (Php19,200.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted at the office website and conspicuous bulletin board in the premises of this Office from June 18, 2025 to June 23, 2025 at 9:00 a.m.;

**WHEREAS**, RFQs were likewise sent to at least four (4) prospective suppliers as follows: (1) God's Treasure Enterprises; (2) Focal Managing Loop Inc.; (3) Pink Parsley Catering Services; and (4) DepEd Region IV-A CALABRAZON Multipurpose Cooperative.

**WHEREAS**, one (1) supplier submitted its proposal; **DEPED REGION IV-A CALABARZON MULTIPURPOSE COOPERATIVE** in the amount of **NINETEEN THOUSAND TWO HUNDRED PESOS (Php19,200.00)**. Thus, **DEPED REGION IV-A CALABARZON MULTIPURPOSE COOPERATIVE** is declared as the lone bidder;

**WHEREAS**, after review and deliberation on the proposals, **DEPED REGION IV-A CALABARZON MULTIPURPOSE COOPERATIVE** complied with the requirements and is hereby declared as the Single Calculated and Responsive Quotation (SCRQ);

**NOW, THEREFORE**, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **DEPED REGION IV-A CALABARZON MULTIPURPOSE COOPERATIVE** in the amount of **NINETEEN THOUSAND TWO HUNDRED PESOS (Php19,200.00)**.
