Thank you for your patience and continued support. We look forward to your participation on the rescheduled date.

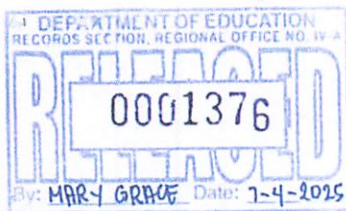

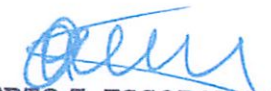
