**PARTICIPATION IN THE THIRD FUTSAL TRAINING CLINIC**

To **Schools Division Superintendents**

1. About the invitation from the University of Asia and the Pacific, this Office, through the Education Support Services Division (ESSD), informs that there will be a Third Futsal Training Clinic on July 12 and 13, 2025 from 8:00 A.M. to 4:00 P.M. at the University of Asia and the Pacific Gym, Ortigas Center, Pasig City.
2. This training clinic is organized by the Alalay sa Pamilya at Bayan Foundation, Inc. (APB) in partnership with UA&P and the Bloomberg Foundation, which aims to prepare teacher-coaches for the upcoming futsal tournaments and support the holistic development of learners through sports.
3. Specifically, the abovementioned activity aims to obtain the following:
  - a. To enhance the skills and competence of teacher-coaches in organizing and coaching school futsal teams.
  - b. To promote human virtues such as sportsmanship, perseverance, patience, and consistency among both learners and educators through organized sports activities.
  - c. To foster camaraderie and friendships among teacher-coaches through collaborative and spirited activities.
  - d. To support the preparation for the upcoming futsal tournaments, starting at the division level and culminating in the selection of regional teams for potential participation in local and national competitions.
4. The participants of this training clinic are teacher-coaches who previously attended the first and second futsal clinics held at Epic Parc, Tanay, Rizal. It will also include other teacher-coaches from schools in CALABARZON and NCR whose institutions have expressed intent to join the School Year 2025–2026 futsal competition.




