This event aims to showcase and promote the major milestone in the implementation of universal feeding for Kindergarten learners. The initiative underscores the Department's strong commitment to improving learning outcomes through early childhood nutrition.

In this connection, this Office respectfully requests the Regional Office and the Schools Division of Antipolo City to host the activity. Should this request be approved, we shall coordinate closely with your offices to ensure smooth planning and implementation, with the goal of delivering a meaningful and productive event for all learners, parents and stakeholders. - c) procurement of meals (breakfast and lunch) for approximately 645 pax;
- d) logistical support (e.g. hosting of the event, sound system, stage decoration, registration materials, transportation and other essential equipment); and
- e) coordination assistance to facilitate local preparations and on-site arrangements.

Additionally, we request the SDO Antipolo City to utilize the downloaded CK operational funds for the showcase feeding activity during the National Launching.
