ADJUSTED TIMELINE FOR THE 10TH DEPED CALABARZON GAWAD PATNUGOT

- 1. Relative to the conduct of the 10th DepEd CALABARZON Gawad Patnugot, this Office, through the HRDD, in collaboration with the Regional PRAISE Committee, releases the adjusted timeline of the search. The adjustments were due to the recent impact of monsoon rains and flooding affecting the schools. The Stage 2 Onsite Validation will be from August 5-29, 2025. Please see attached the adjusted schedule and the list of regional validators.
- 2. To stay updated on the onsite validation process, SDO R&R focal persons, alternates, and other concerned individuals may access this link, https://tinyurl.com/links-10thGP-SDOs. It provides essential information such as the validation schedule, regional validators, a feedback link, and a folder for uploading photos and videos from the documenters.
- 3. The Regional PRAISE Committee reiterates to all regional validators and qualifiers to observe and be guided by RA 6713 otherwise known as the Code of Conduct and Ethical Standards for Public Officials and Employees specifically Section 7d, "Public officials and employees shall not solicit or accept, directly or indirectly, any gift, gratuity, favor, entertainment, loan or anything of monetary value from any person in the course of their official duties or in connection with any operation being regulated by, or any transaction which may be affected by the functions of their office."
- 4. This Office also requests the assistance of the schools division offices for the provision of service vehicles to transport validators to the next SDO. Expenses incurred by the schools and SDOs relative to the Stage 2 Onsite Validation shall be charged against their local funds, while the travel expenses, board and lodging, and other related miscellaneous expenses of the regional validators
