BAC RESOLUTION

RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO GRAND MONACO PREMIER HOTEL INC. FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE WORKSHOP ON THE QUALITY ASSURANCE OF SDO CONTEXTUALIZED LEARNING RESOURCES (PHASE 1) ON JUNE 30-JULY 3, 2025

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **WORKSHOP ON THE QUALITY ASSURANCE OF SDO CONTEXTUALIZED LEARNING RESOURCES (PHASE 1) ON JUNE 30-JULY 3, 2025**;

WHEREAS, the Approved Budget for the Contract (ABC) is **THREE HUNDRED THIRTY-SIX THOUSAND PESOS (Php336,000.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) on June 19, 2025, at the office website and conspicuous bulletin board in the premises of this Office from June 18, 2025 to June 23, 2025 at 9:00 a.m.;

WHEREAS, RFQs were likewise sent to at least three (3) prospective suppliers as follows: (1) Cristina Villas Mountain Resort & Hotel Inc.; (2) Loreland Realty & Development Corp.; and (3) Grand Monaco Premier Hotel Inc.;

WHEREAS, one (1) supplier submitted its proposal; **GRAND MONACO PREMIER HOTEL INC.** in the amount of **THREE HUNDRED THIRTY-FIVE THOUSAND ONE HUNDRED SIXTY PESOS (Php335,160.00)**. Thus, **GRAND MONACO PREMIER HOTEL INC.** is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposals, **GRAND MONACO PREMIER HOTEL INC.** complied with the requirements and is hereby declared as the Single Calculated and Responsive Quotation (SCRQ);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **GRAND MONACO PREMIER HOTEL INC.** in the amount of **THREE HUNDRED THIRTY-FIVE THOUSAND ONE HUNDRED SIXTY PESOS (Php335,160.00)**.
