## BAC RESOLUTION

**RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO TAGAYTAY AUTOMART, INC. - TAGAYTAY COUNTRY HOTEL FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE WORKSHOP ON THE UNIFICATION AND ENHANCEMENT OF CURRICULUM FOR THE SPECIAL CURRICULAR PROGRAM IN SCIENCE ON AUGUST 12-14, 2025**

**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **WORKSHOP ON THE UNIFICATION AND ENHANCEMENT OF CURRICULUM FOR THE SPECIAL CURRICULAR PROGRAM IN SCIENCE ON AUGUST 12-14, 2025**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **THREE HUNDRED THOUSAND PESOS (Php300,000.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) on July 18, 2025, at the office website and conspicuous bulletin board in the premises of this Office from July 17, 2025 to July 21, 2025 at 9:00 a.m.;

**WHEREAS**, RFQs were likewise sent to at least four (4) prospective suppliers as follows: (1) Tagaytay Automart, Inc. - Tagaytay Country Hotel; (2) Sunny Glades Properties Corp. (Tagaytay Haven Hotel); (3) Country Chateau Hoteliers Corporation (Country Chateau Hotel) and (4) Tagaytay Viewpark Hotel;

**WHEREAS**, one (1) supplier submitted its proposal; **TAGAYTAY AUTOMART, INC. - TAGAYTAY COUNTRY HOTEL** in the amount of **TWO HUNDRED NINETY-TWO THOUSAND FIVE HUNDRED PESOS (Php292,500.00)**. Thus, **TAGAYTAY AUTOMART, INC. - TAGAYTAY COUNTRY HOTEL** is declared as the lone bidder;

**WHEREAS**, after review and deliberation on the proposals, **TAGAYTAY AUTOMART, INC. - TAGAYTAY COUNTRY HOTEL** complied with the requirements and is hereby declared as the Single Calculated and Responsive Quotation (SCRQ);

**NOW, THEREFORE**, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **TAGAYTAY AUTOMART, INC. - TAGAYTAY COUNTRY HOTEL** in the amount of **TWO HUNDRED NINETY-TWO THOUSAND FIVE HUNDRED PESOS (Php292,500.00)**.


