**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **TRAINING-WORKSHOP ON SYNCHRONIZED GAD PLANNING AND BUDGETING CUM PREPARATION OF GAD ACCOMPLISHMENT REPORT ON AUGUST 6-8, 2025**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **THREE HUNDRED SIXTY THOUSAND PESOS (Php360,000.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) on July 17, 2025, at the office website and conspicuous bulletin board in the premises of this Office from July 16, 2025 to July 21, 2025 at 9:00 a.m.;

**WHEREAS**, RFQs were likewise sent to at least three (3) prospective suppliers as follows: (1) Madison 101 Hotel; (2) Red Hotel Inc.; and (3) Sunrise Ridge Corporation (Soleste Suites);

**WHEREAS**, four (4) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:
