WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES** for the **GAWAD PATNUGOT INTERVIEW (STAGE 3) ON AUGUST 28-29, 2025**;

WHEREAS, the Approved Budget for the Contract (ABC) is **NINE THOUSAND SIX HUNDRED PESOS (Php9,600.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted at the office website and conspicuous bulletin board in the premises of this Office from August 12, 2025 to August 18, 2025 at 9:00 a.m.;

WHEREAS, RFQs were likewise sent to at least five (5) prospective suppliers as follows: (1) God's Treasure Enterprises; (2) Focal Managing Loop Inc.; (3) Pink Parsley Catering Services; (4) DepEd Region IV-A CALABRAZON Multipurpose Cooperative; and (5) Plato ni Juan;

WHEREAS, two (2) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:
