**WHEREAS**, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **TURNAROUND SCHOOL PROGRAM AND ACCREDITATION GUIDELINES CONSULTATIVE CONFERENCE ON SEPTEMBER 23-26, 2025**;

**WHEREAS**, the Approved Budget for the Contract (ABC) is **FOUR HUNDRED SIXTY-FOUR THOUSAND PESOS (Php464,000.00)**;

**WHEREAS**, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

**WHEREAS**, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) on August 28, 2025, at the office website and conspicuous bulletin board in the premises of this Office from August 27, 2025 to September 1, 2025 at 9:00 a.m.;

**WHEREAS**, RFQs were likewise sent to at least three (3) prospective suppliers as follows: (1) Sunrise Ridge Corporation (Soleste Suites); (2) Red Hotel, Inc.; and (3) Madison 101 Hotel;

**WHEREAS**, two (2) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:
