WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING** SERVICES for the CONDUCT OF NATIONAL QUALITY SYSTEM (NOMS) RECERTIFICATION AUDIT FOR PILOT MANAGEMENT OFFICES ON SEPTEMBER 11-12, 2025;

WHEREAS, the Approved Budget for the Contract (ABC) is ONE HUNDRED ELEVEN THOUSAND PESOS (Php111,000.00);

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof:

WHEREAS, the Request for Quotation (RFQ) was posted in the Philippine Government Electronic Procurement System (PhilGEPS) on August 28, 2025, at the office website and conspicuous bulletin board in the premises of this Office from August 27, 2025 to September 1, 2025 at 9:00 a.m.;

WHEREAS, RFQs were likewise sent to at least four (4) prospective suppliers as follows: (1) God's Treasure Enterprises; (2) Focal Managing Loop Inc.; (3) DepEd Region IV-A CALABRAZON Multipurpose Cooperative; and (4) Plato ni Juan;

WHEREAS, two (2) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:
