RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO FOCAL MANAGING LOOP INC. FOR THE PROCUREMENT OF CATERING SERVICES FOR THE CONDUCT OF 'UMALOHOKAN: DEPED CALABARZON INFORMATION OFFICERS' CONVERGENCE' YEAR 2 (PHASE 3) ON AUGUST 15, 2025

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **CATERING SERVICES** for the **CONDUCT OF 'UMALOHOKAN: DEPED CALABARZON INFORMATION OFFICERS' CONVERGENCE' YEAR 2 (PHASE 3) ON AUGUST 15, 2025**;

WHEREAS, the Approved Budget for the Contract (ABC) is **THIRTY-SIX THOUSAND PESOS (Php36,000.00)**;

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations (R-IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act of 2003", allows an agency to resort to Small Value Procurement as alternative method of procurement where the amount involved does not exceed the threshold amount of One Million Pesos (Php1,000,000.00) as prescribed in Annex "H" thereof;

WHEREAS, the Request for Quotation (RFQ) was posted at the office website and conspicuous bulletin board in the premises of this Office from July 17, 2025 to July 22, 2025 at 9:00 a.m.;

WHEREAS, RFQs were likewise sent to at least five (5) prospective suppliers as follows: (1) God's Treasure Enterprises; (2) Focal Managing Loop Inc.; (3) Pink Parsley Catering Services; (4) DepEd Region IV-A CALABRAZON Multipurpose Cooperative; and (5) Plato ni Juan;

WHEREAS, one (1) supplier submitted its proposal; **FOCAL MANAGING LOOP INC.** in the amount of **THIRTY-SIX THOUSAND PESOS (Php36,000.00)**. Thus, **FOCAL MANAGING LOOP INC.** is declared as the lone bidder;

WHEREAS, after review and deliberation on the proposals, **FOCAL MANAGING LOOP INC.** complied with the requirements and is hereby declared as the Single Calculated and Responsive Quotation (SCRQ);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **FOCAL MANAGING LOOP INC.** in the amount of **THIRTY-SIX THOUSAND PESOS (Php36,000.00)**.




