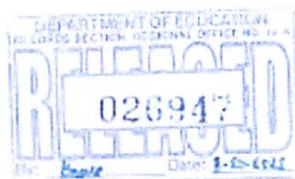

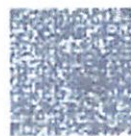

**TURN AROUND SCHOOL PROGRAM AND ACCREDITATION
GUIDELINES CONSULTATIVE CONFERENCE**

To: Schools Division Superintendents

1. In reference to DepEd Order No.7, s. 2024¹, this Office through the Field Technical Assistance Division will conduct a Turnaround School Program and Accreditation Guidelines Consultative Conference on September 23-26, 2025, at a venue that will later be announced.
2. The activity aims to:
 - a. review and assess the current draft guidelines on the Turn Around School Program and accreditation standards, ensuring alignment with national education policies;
 - b. recalibrate the draft guidelines based on evidence, best practices, and stakeholder input, with the goal of improving school performance and accreditation outcomes;
 - c. ensure that the revised guidelines promote inclusivity, transparency, and accountability in the implementation of the Turn Around School Program and accreditation processes; and
 - d. develop a roadmap for the implementation, monitoring, and periodic review of the recalibrated guidelines, establishing mechanisms for ongoing stakeholder engagement and feedback.
3. The participants in this activity from the Schools Division Office are select Assistant Schools Division Superintendents, 23 Public Schools District Supervisors and 23 School Heads.
4. Travel and other related expenses of the participants shall be charged against their local funds, subject to the existing accounting and auditing rules and regulations of the Department.

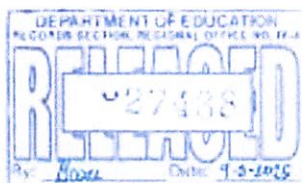
