Regional Memorandum No.659 s.2025

COMPETENCY ENHANCEMENT TRAINING FOR FUTURE LEADERS

To: Schools Division Superintedents

- The role of an Assistant Schools Division Superintendent (ASDS) is crucial in ensuring the effective and efficient delivery of basic education services within a Schools Division Office (SDO). ASDS, OIC-ASDS, and aspiring ASDS face multifaceted responsibilities that require strong leadership, sound decisionmaking, and a deep understanding of educational governance, policies, and management systems.
- 2. One of the requirements of the Career Executive Service (CES) Board is that future executives must possess the managerial skills and leadership competencies necessary for appointment and performance in higher executive positions.
- 3. Anent this, the Office in coordination with the Human Resource Development Division–National Academy of the Philippines in the Region (HRDD NEAP R) will conduct a **Competency Enhancement Training for Future Leaders (CETFL)** on October 14-16, 2025. The venue will be announced through an advisory.
- 4. This training aims the participants to:
 - a. Demonstrate enhanced managerial competencies in planning, organizing, leading, and controlling educational programs and operations.
 - b. Apply strategic thinking and evidence-based decision-making in addressing organizational and systemic challenges.
 - c. Strengthen skills in people management, conflict resolution, and team motivation to foster a collaborative and high-performing work environment.
 - d. Exhibit ethical leadership and accountability aligned with the core values of public service and the standards of the CES Board.
 - e. Develop adaptive leadership capabilities to respond effectively to emerging issues, policy shifts, and organizational reforms in the education sector.
