WRITESHOP ON RESOLUTION AND DECISION WRITING

To: Schools Division Superintendent:

- 1. Section 42 of DepEd Order No. 49, Series of 2016¹ provides that the disciplining authority shall render his decision on the case after receipt of the investigation report.
- 2. The Legal Unit of this Regional Office is confronted with an increasing number of Formal Investigation Reports and Fact-finding Investigation Reports to be reviewed by two (2) Lawyers who were assigned on the matter. On the other hand, DepEd Order No. 49 S. 2006 provides that the disciplining authority shall render his decision within thirty (30) days from receipt of the report of investigation.
- 3. In order to comply with the mandates of DepEd Order No. 49, S. 2006, all Attorneys from the different Legal Unit of the schools division offices are hereby required to attend the "Writeshop on Resolution and Decision Writing" which will be held on October 20-24, 2025 and December 1-5, 2025. The venue will be announced in a separate advisory.
- 4. The travel expenses and related expenses of the participants relative to the conduct of this activity shall be charged to their respective local funds, subject to the usual accounting and auditing rules and regulations.
