RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO MARAWI LEISURE PARK INC (TANZA OASIS HOTEL AND RESORT), M.I. SEVILLA RESORT, GREAT EASTERN HOTEL, INC., AND SELAH PODS HOTEL INC. FOR THE PROCUREMENT OF LEASE OF VENUE WITH FOOD AND ACCOMMODATION FOR THE REGIONAL TRAINING OF SCHOOL LEADERS ON REVISED K TO 10 CURRICULUM IMPLEMENTATION

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **LEASE OF VENUE WITH FOOD AND ACCOMMODATION** for the **REGIONAL TRAINING OF SCHOOL LEADERS ON REVISED K TO 10 CURRICULUM IMPLEMENTATION ON SEPTEMBER 15-19, 22-26, SEPTEMBER 29-OCTOBER 3, OCTOBER 6-10, 13-17, 20-24, 2025;**

WHEREAS, the Approved Budget for the Contract (ABC) are as follows;

WHEREAS, Rule XVI, Section 48.2 of the IRR of R.A. 9184, otherwise known as the "Government Procurement Reform Act of 2003" provides the general rule that public bidding is the general mode of procurement. However, the same section allows procuring entities to resort to alternative methods of procurement such as Negotiated Procurement subject to the approval of the Head of the Procuring Entity;

WHEREAS, Rule XVI, Section 53.10 of the IRR of R.A. 9184 allows Negotiated Procurement under Lease of Real Property and Venue as a mode of procurement subject to the approval of the Head of Procuring Entity;

WHEREAS, the BAC thru its Secretariat, initiated the procurement activity by requesting for quotation from fifteen (15) prospective suppliers as follows:

Following the ocular inspections conducted, The Human Resource Development Division-National Educators Academy of the Philippines in the Region (HRDD-NEAPR) hereby reports the results and significant observations/findings in relation to the prescribed specifications, to wit:*

WHEREAS, based on the result of the ocular inspection reflected in the Rating Factors and Determination of Reasonableness of Rental Rate for **Lot 1, TAGAYTAY AUTOMART INC - TAGAYTAY COUNTRY HOTEL** has been rated by with the score of **79.65%**, and **MARAWI LEISURE PARK INC (TANZA OASIS HOTEL AND RESORT)** has been rated by with the score of **91.55%**;

WHEREAS, based on the result of the ocular inspection reflected in the Rating Factors and Determination of Reasonableness of Rental Rate for **Lot 2, M.I. SEVILLA RESORT** has been rated by with the score of **90.65%**;

WHEREAS, based on the result of the ocular inspection reflected in the Rating Factors and Determination of Reasonableness of Rental Rate for **Lots 3 and 4, GREAT EASTERN HOTEL, INC.** has been rated by with the score of **85.25%**, **RED HOTEL, INC.** has been rated by with the score of **79.70%**, and **SELAH PODS HOTEL INC.** has been rated by with the score of **92.65%**;

WHEREAS, the report containing the result of the evaluation and its attachments is attached hereto as Annex "A", Annex "B", Annex "C", Annex "D", Annex "E" and Annex "F" and made an integral part hereof;

WHEREAS, after review and deliberation on the proposals of **TAGAYTAY AUTOMART INC - TAGAYTAY COUNTRY HOTEL** for **Lot 1** and **RED HOTEL, INC.** for **Lots 3 and 4** are non-compliant for the said activity due to the above-mentioned reason;

WHEREAS, based on the ocular inspection, the suppliers can only cater one (1) lot of the said event based on the specifications of the end-user;

WHEREAS, the BAC decided to award one (1) lot per supplier to accommodate the said event;

WHEREAS, upon evaluation or careful examination of the technical specification submitted, the BAC found that:

- a. **MARAWI LEISURE PARK INC (TANZA OASIS HOTEL AND RESORT)**, is compliant with its proposal for **Lot 1** in the total amount of **TWELVE MILLION THREE HUNDRED EIGHTY-EIGHT THOUSAND NINE HUNDRED FIFTY PESOS (Php12,388,950.00)** and is hereby declared as the Single Calculated and Responsive Quotation (SCRQ) for **Lot 1**;
- b. **M.I. SEVILLA RESORT**, is compliant with its proposal for **Lot 2** in the total amount of **ELEVEN MILLION THREE HUNDRED TWENTY-ONE THOUSAND FIVE HUNDRED SEVENTY PESOS (Php11,321,570.00)** and is hereby declared as the Single Calculated and Responsive Quotation (SCRQ) for **Lot 2**;
- c. **GREAT EASTERN HOTEL, INC.**, is compliant with its proposal for **Lot 3** in the total amount of **ELEVEN MILLION THIRTY-SEVEN THOUSAND PESOS (Php11,037,000.00)** and is hereby declared as the Lowest Calculated and Responsive Quotation (LCRQ) for **Lot 3**;
- d. **SELAH PODS HOTEL INC.**, is compliant with its proposal for **Lot 4** in the total amount of **ELEVEN MILLION THIRTY THOUSAND**

PESOS (Php11,030,000.00) and is hereby declared as the Responsive Quotation (RQ) for **Lot 4**;

NOW, THEREFORE, the BAC hereby **RESOLVES**, as it hereby **RESOLVED**:

1. **To DECLARE** the quotations of **TAGAYTAY AUTOMART INC - TAGAYTAY COUNTRY HOTEL** for **Lot 1** and **RED HOTEL, INC.** for **Lots 3 and 4** as ineligible bidders for failure to comply with the required specification issued by this Office;
2. **To DECLARE** the quotation of **MARAWI LEISURE PARK INC (TANZA OASIS HOTEL AND RESORT)** as the Single Calculated and Responsive Quotation (SCRQ) for **Lot 1** in the amount of **TWELVE MILLION THREE HUNDRED EIGHTY-EIGHT THOUSAND NINE HUNDRED FIFTY PESOS (Php12,388,950.00)**;
3. **To DECLARE** the quotation of **M.I. SEVILLA RESORT** as the Single Calculated and Responsive Quotation (SCRQ) for **Lot 2** in the amount of **ELEVEN MILLION THREE HUNDRED TWENTY-ONE THOUSAND FIVE HUNDRED SEVENTY PESOS (Php11,321,570.00)**;
4. **To DECLARE** the quotation of **GREAT EASTERN HOTEL, INC.** as the Lowest Calculated and Responsive Quotation (LCRQ) for **Lot 3** in the amount of **ELEVEN MILLION THIRTY-SEVEN THOUSAND PESOS (Php11,037,000.00)**;
5. **To DECLARE** the quotation of **SELAH PODS HOTEL INC.** as the Responsive Quotation (RQ) for **Lot 4** in the amount of **ELEVEN MILLION THIRTY THOUSAND PESOS (Php11,030,000.00)**;
6. **To RECOMMEND** to the Regional Director, as the Head of Procuring Entity, the award of the project:
