# WITHDRAWAL/CANCELLATION OF THE DOWNLOADED SUB-ARO FOR THE MODERNIZATION PLAN (DECENTRALIZATION OF ASSESSMENT DIGITALIZATION PACKAGE) FOR NASBE PROGRAMS

#### To All Schools Division Superintendents

- 1. Pursuant to DepEd Memorandum (DM-OSEC-2025-07) entitled "Guidelines on the Use of Program Support Fund (PSF) for the Modernization Plan (Decentralization of Assessment Digitization Package) for the National Assessment Systems for Basic Education Programs," the Bureau of Education Assessment (BEA) downloaded the Sub-Aro No. OSEC-4A-25-04577 to this Office dated September 15, 2025 which was also downloaded to all SDOs. The purpose of the downloaded funds is to procure the Assessment Digitization Package, which includes hardware scanners, Optical Mark Recognition (OMR) software, and desktop computers. These items shall be distributed to the Schools Division Offices (SDOs) within the Region to support the implementation of the modernization plan for assessment processes.
- 2. In this regard, to ensure a more efficient and streamlined procurement process, this Office has decided to take charge of procuring the Assessment Digitization Package. It will handle the centralized procurement of the Assessment Digitization Package to ensure compliance with existing policies and to promote economy, consistency and accountability in the implementation. Consequently, the Regional Office Finance Division will issue a negative Sub-ARO to the Schools Division Offices.
- 3. Immediate dissemination of this memorandum is highly desired.
