BAC RESOLUTION

RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO AZTECO CORPORATION (AXIAA HOTEL) FOR THE PROCUREMENT OF FOOD AND ACCOMMODATION FOR THE CONDUCT OF THE LEARNER RIGHTS AND PROTECTION SPECIALIZATION COURSE

WHEREAS, DepEd Regional Office IV-A CALABARZON has undertaken procurement of **FOOD AND ACCOMMODATION** for the **CONDUCT OF THE LEARNER RIGHTS AND PROTECTION SPECIALIZATION COURSE ON OCTOBER 15-17, 2025**;

WHEREAS, the Approved Budget for the Contract (ABC) is **SEVEN HUNDRED NINETY-TWO THOUSAND PESOS (Php792,000.00)**;

WHEREAS, Section 26.1 (h) of the Implementing Rules and Regulations (IRR) of Republic Act No. 12009 otherwise known as the “New Government Procurement Act”, provides for Small Value Procurement as one of the modes of Procurement consistent with the Fit-for-Purpose procurement approach;

WHEREAS, Section 34. Small Value of Procurement states that:

“Section 34. Small Value Procurement

34.1 Small Value Procurement (SVP) is a mode of procurement whereby the Procuring Entity requests for the submission of at least three (3) price quotations for Goods not available in the PS-DBM, Infrastructure Project, and Consulting Services.

The receipt of one (1) quotation is sufficient to proceed with the evaluation of bidders; Provided, that, the amount involved does not exceed Two Million Pesos (Php2,000,000.00), subject to the periodic review of the threshold amount and adjustments as may be deemed appropriate by the GPPB.”

WHEREAS, Section 34.3 (a) of the said IRR, the End-User or Implementing Unit shall submit a request for Small Value Procurement to the BAC. The request shall indicate the Technical Specifications, Scope of Work, Terms of Reference, as the case may be, Approved Budget for the Contract and other terms and conditions;

WHEREAS, on September 16, 2025, the End-User submitted their request to procure the said item/s under SVP - mode of procurement to the Bids and Awards Committee (BAC), which includes the following:

- Approved Purchase Requests;
- Approved Budget for the Contract (ABC);

WHEREAS, two (2) suppliers submitted their respective proposals before the deadline for the submission of quotations, offering the following financial quotations, as read:

WHEREAS, on September 24, 2025, the Procurement Unit received a letter from **GREEN SUN HOTEL MANAGEMENT INC.** informing this office that the venue is no longer available on the date specified in the RFQ. Attached is the letter as Annex "A" and made an integral part hereof;


WHEREAS, GREEN SUN HOTEL MANAGEMENT INC. failure to adhere to the terms in accordance with the specifications of the RFQ vis-à-vis the LCRQ's submitted proposal, thus the BAC, resolved to declare non-compliance with the technical specification set by this office the quotation of **GREEN SUN HOTEL MANAGEMENT INC.**;

WHEREAS, upon evaluation or careful examination of the proposal submitted by **AZTECO CORPORATION (AXIAA HOTEL)**, the BAC found that it was compliant with the proposed amount of **SEVEN HUNDRED EIGHTY-EIGHT THOUSAND PESOS (Php788,000.00)**;

WHEREAS, after review and deliberation on the proposals, **AZTECO CORPORATION (AXIAA HOTEL)** complied with the requirements and is hereby declared as the Single Calculated and Responsive Quotation (SCRQ);

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED** to **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of the project to **AZTECO CORPORATION (AXIAA HOTEL)** in the amount of **SEVEN HUNDRED EIGHTY-EIGHT THOUSAND PESOS (Php788,000.00)**;
