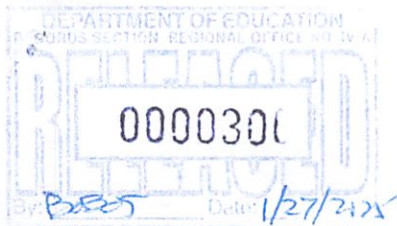
In reference to the Regional Memorandum No. 65, s. 2025¹, this Office informs
