The Office of the Undersecretary for Curriculum and Teaching (OUCT), through the Bureau of Learning Delivery (BLD), shall conduct a series of workshops on the **Development of Play-based Modules to Develop Physical Movement and Social Interaction in Key Stage 1**.

This series of workshops is an innovative initiative designed to enhance the learning experience of Key Stage 1 learners by integrating play-based strategies into existing lesson exemplars. Given that the revised K-12 curriculum does not include Physical Education as a standalone subject—limiting opportunities for physical movement and social interaction mainly to MAKABANSA—this initiative seeks to address the gap by embedding structured, interactive, and movement-based activities into daily instruction. The workshops for development, validation, revision, and finalization will be attended by selected supervisors, master teachers, and school heads. To ensure continuity and consistency in the materials, the same participants should be involved throughout the development, revision, and finalization phases. Meanwhile, the orientation on utilization will be conducted for the Chief Education Program Supervisors at the regional and division levels.

Participants are required to bring their approved travel order, reference materials, laptop, and extension wires. Confirmation of attendance must be made by completing the online registration form at https://bit.ly/ELLN_Play-based_2025 on or before the following deadlines:

Travel dates must adhere to the program schedule outlined in **Annex B**, which specifies that AM snacks and PM snacks will be provided as the first and last meal for each activity phase, respectively. The detailed activity matrix will be distributed on the first day of each session. Board and lodging expenses shall be charged against the **2024 ELLN Continuing Funds**, while the travel expenses shall be charged against the ELLN Funds downloaded to your regions. In the event of insufficient funds, additional costs may be covered by available local funds, subject to applicable accounting rules and regulations.

Compensatory Time-Off (CTO) will be granted in lieu of workshop days that will fall on holidays, in accordance with DepEd Order No. 53, s. 2023, Updated Guidelines on Grant of Vacation Service Credits to Teachers, and CSC-DBM Joint Circular No. 2, s. 2015, Policies and Guidelines on Overtime Services and Overtime Pay for Government Employees.

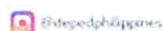
