Regional Memorandum No. 791, s. 2025

DATA-DRIVEN GOVERNANCE: REVIEWING THE QBEDP-ALIGNED PLANS AND INFORMATION SYSTEMS IMPLEMENTATION

To Schools Division Superintendents All Others concerned

- 1. In line with the Department's continuing commitment to evidence-based planning and decision-making, and following the Development of the Midterm Plan for 2026–2028 under Regional Memorandum No. 390, s. 2025 and Regional Advisory No. 133, s. 2025, the Department of Education (DepEd) shall assess the progress of Schools Division Offices (SDOs) in aligning their midterm plans with the Quality Basic Education Development Plan (QBEDP). This activity likewise reinforces the proper implementation of key DepEd information systems—namely, the Learner Information System (LIS), Basic Education Information System (BEIS), and National School Building Inventory (NSBI)—as stipulated in DepEd Orders Nos. 27, s. 2019, 1, s. 2017, and 29, s. 2022, which are essential tools for ensuring data accuracy, transparency, and effective monitoring in basic education governance.
- 2. In view of the foregoing, this Office, through the Policy, Planning, and Research Division (PPRD), will conduct the *Data-Driven Governance: Reviewing the QBEDP-Aligned Plans and Information Systems Implementation* on December 4–5, 2025. Venue details shall be issued in a separate advisory.
- 3. This activity aims to gauge the overall progress of the region in both midterm plan preparation and data management implementation. Specifically, participants are expected to:
 - a. be informed of the timeline and procedures in developing and finalizing their QBEDP-aligned Midterm Plan for 2026–2028;
 - b. gain a comprehensive understanding of the regional and SDO performance in implementing key information systems;
 - c. identify and analyze key issues and challenges encountered during implementation; and
 - d. formulate practical strategies and solutions to improve the efficiency and effectiveness of future implementation cycles.
