**READING LEADERS SUMMIT: ADVANCING LITERACY
THROUGH THE EARLY LANGUAGE, LITERACY
AND NUMERACY (ELLN) PROGRAM**

To **Schools Division Superintendents**

1. In line with the Department of Education CALABARZON's commitment to strengthen foundational skills in reading, literacy, and numeracy, this Office, through the Curriculum and Learning Management Division (CLMD), will spearhead the Reading Leaders Summit: Advancing Literacy through the ELLN Program on December 15-19, 2025, at a venue that will be announced through a separate issuance.
2. This activity aims to:
 - a. analyze division-level literacy and numeracy data to identify priority areas and gaps in foundational skills;
 - b. strengthen instructional leadership competencies in reading, literacy, and numeracy to effectively mentor and support school heads and teachers;
 - c. design and align division-level plans and strategies for the effective implementation of the ELLN Program;
 - d. enhance collaboration between CID and SGOD, and among EPSs in English, Filipino, Mathematics, and ELLN, to ensure coherent program delivery and monitoring; and
 - e. apply milestone-based monitoring and evaluation tools to track learner progress and ensure sustainable improvements in literacy and numeracy outcomes.
3. Participants in this activity are Chief Education Supervisors of the Curriculum Implementation Division (CID) and School Governance and Operations Division (SGOD) together with the Education Program Supervisors in ELLN, Filipino, English, and Mathematics. The list of participants, together with the Indicative Program of Activities with the list of field testing sites, Program Management Team (PMT), and Terms of Reference (ToR) will be issued through a separate memorandum.

4. Food and accommodation of the participants shall be charged against the ELLN 2025 Current Funds. Meanwhile, transportation and incidental expenses of all participants including the Regional Office Personnel may be charged against any available local funds, subject to the usual government accounting and auditing rules and regulations.
