# REGIONAL TRAINING OF SCHOOL HEADS ON REVISED K TO 10 CURRICULUM IMPLEMENTATION – BATCH 5

#### To: Schools Division Superintendents

- 1. To ensure that all school heads are fully capacitated on the Revised K to 10 curriculum implementation, this Office, through the Human Resource Development Division-National Educators Academy of the Philippines in the Region (HRDD-NEAPR), in collaboration with Curriculum and Learning Management Division (CLMD) and Quality Assurance Division (QAD), will conduct the Regional Training of School Leaders on Revised K to 10 Curriculum Implementation- Batch 5 on December 15-19, 2025, at a venue to be disseminated in a separate issuance.
- 2. By the end of the training, the school heads will be able to develop and present a context-based Professional Development Plan and a School Leadership Masterplan aligned with the Revised K to 10 Curriculum, using relevant tools, data, and stakeholder input.

Specifically, they will be able to:

- a. apply the principles of the Whole School Approach (WSA) in school operations, curriculum planning, and leadership practices aligned with professional standards;
- b. strengthen instructional coaching and supervision by using effective pedagogical frameworks;
- utilize assessment data for instructional decision-making and schoolwide improvement;
- d. examine and develop teaching and learning resources aligned with curriculum standards;
- e. analyze school context and apply collaborative planning strategies;
- f. design context-based professional development plans aligned with teacher needs and curriculum demands;

- g. integrate performance data and documented practices into school leadership and supervision processes;
- h. apply monitoring and evaluation frameworks for sustainable leadership and school development; and,
- i. use school-based research and analytics to inform leadership decisions and improvements.
- 3. Target participants in the training are the remaining untrained **School Heads** of elementary schools (K-6), junior high schools (7-10), and integrated schools (K-10, K-12, & 7-12). Please see **Enclosure 1** for the number of participants per Division.
- Schools Division Offices (SDOs), through the Human Resource Development Section (HRDS), are requested to submit the Lists of Participants through tinyurl.com/4ASLRevisedK10 on or before November 28, 2025. Templates can be accessed at tinyurl.com/4ASLRevisedK10Paxs.
- 5. The Lists of Participants, Faculty, and Program Management Team Members will be disseminated also in separate issuance.
- 6. Board and lodging expenses shall be charged against the Human Resource Development Fund (Program Support Fund), while travel expenses shall be charged against the fund to be downloaded, subject to the usual accounting and auditing rules and regulations.
