INVITATION FOR THE CONDUCT OF THE SCHOOL HEALTH PERSONNEL CONVERGENCE 2025

To Schools Division Superintendents

- 1. Relative to OM-OASOPS-2025-08-06834¹, this Office, through the Education Support Services Division, hereby announces the conduct of the School Health Personnel Convergence 2025 on December 1-4, 2025, within Region VI. The exact venue will be issued separately by the DepEd Central Office.
- 2. This year's activity adopts the theme, "Synergy in School Health: Strengthening Healthy Learning Institutions through Multidisciplinary Collaboration."
- 3. This event aims to reinforce partnerships among learners, educators, and stakeholders to enhance health awareness and promote healthy behaviors in schools nationwide. It further seeks to showcase regional practices, align program implementation, and build capacity among school health personnel.
- 4. The list of participants from the Regional Office and Schools Division Offices (SDOs) is provided in **Annex A**.
- 5. The prescribed dress code and the CALABARZON flaglet layout are detailed in **Annex B**.
- 6. Travel expenses for this activity shall be charged against the 2024 travel funds for the School Health Personnel Convergence, which will be downloaded by the Regional Office to the respective SDOs. A detailed breakdown of fund allocation per SDO is provided in **Annex C**. Should there be deficiencies in the downloaded funds, expenses may be augmented using the Program Support Funds (PSF), School-Based Feeding Program (SBFP) funds, or local funds, subject to the usual accounting and auditing rules and regulations.


