**POST-EVALUATION ACTIVITY ON THE TRAININGS OF  
TEACHERS AND SCHOOL LEADERS ON THE REVISED  
K TO 10 CURRICULUM IMPLEMENTATION**

To: **Schools Division Superintendents**

1. To evaluate the effectiveness of the Regional Training of School Leaders and School-based Training of Teachers Revised K to 10 Curriculum Implementation, this Office, through the Human Resource Development Division-National Educators Academy of the Philippines (HRDD-NEAP) in collaboration with the Quality Assurance Division (QAD) and the Curriculum and Learning Management Division (CLMD), will conduct the **Post-Evaluation Activity on the Trainings of Teachers and School Leaders on the Revised K to 10 Curriculum Implementation** on **December 17-19, 2025**, at a venue to be disseminated in a separate issuance.
2. The activity aims to:
  - a. present the results of monitoring and evaluation (M&E) for the Revised K to 10 Curriculum Implementation – Phase 2;
  - b. discuss best practices, issues, and concerns captured by the M&E tools; and,
  - c. conduct strategic planning on the implementation of Revised K to 10 Curriculum Trainings – Phase 3.
3. Participants in this activity are the select Regional Office Personnel from HRDD, QAD, and CLMD, and SDO Personnel, to wit:
  - a. Chief Education Supervisors from the Curriculum and Implementation Division (CID) and School Governance and Operations Division (SGOD);
  - b. Senior Education Program Specialist and Education Program Specialist II from Human Resource Development Section; and,
  - c. Senior Education Program Specialist from Monitoring and Evaluation Section.

4. Board and lodging expenses shall be charged against the Regional HRD Fund, while travel and other incidental expenses shall be charged against local funds subject to the usual accounting and auditing rules and regulations.
