- In reference to National Budget Memorandum No. 156, dated January 5, 2026, entitled National Budget Call for FY 2027, the Finance Division will conduct a Seminar-Workshop on the Conduct of FY 2027 Budget Proposal with the finance personnel of schools division offices on February 16-17, 2026. The venue will be announced through a separate regional advisory.
- The objectives of this activity are as follows:
  - Validate the consolidated budget proposals of Schools Division Offices (SDOs);
  - Ensure the completeness and accuracy of submitted budget proposals; and
  - Provide technical support to SDOs during the consolidation process.
- Participants in this seminar-workshop are the Schools Division Budget Officers and selected Finance staff of the Regional Office Proper.
- Funding Arrangements:
  - Food and accommodation expenses shall be charged to Regional Office Funds.
  - Travel expenses shall be charged against local funds, subject to the usual budgeting, accounting, and auditing rules and regulations.

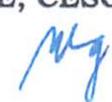
