BAC RESOLUTION

RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY THE AWARD OF CONTRACT TO VECO PAPER CORPORATION FOR THE PROCUREMENT OF SUPPLY AND DELIVERY OF IBONG ADARNA AND FLORANTE AT LAURA SUPPLEMENTARY READING FOR GRADE 7 AND 8 FOR SY 2025-2026 WITH REFERENCE NUMBER ROIVA-25-12

WHEREAS, on October 23, 2025, DepEd Regional Office IV-A CALABARZON has published its procurement activity for the **SUPPLY AND DELIVERY OF IBONG ADARNA AND FLORANTE AT LAURA SUPPLEMENTARY READING FOR GRADE 7 AND 8 FOR SY 2025-2026** with reference number **ROIVA-2025-12** in the PhilGEPS website, office website, and in conspicuous bulletin board of the Office;

WHEREAS, on October 20, 2025, the Bids and Awards Committee (BAC), Technical Working Group (TWG), BAC Secretariat and End-user conducted a pre-procurement conference to discuss the said allotment and approved the bid documents for the Procurement of Technical-Vocational-Livelihood (TVL) Equipment Packages to Public Senior High Schools;

WHEREAS, the Approved Budget for the Contract (ABC) are as follows:

WHEREAS, on November 3, 2025, Pre-bid Conference was held, followed by a Bid Submission and Opening on November 24, 2025;

WHEREAS, Bid Bulletin No. 10, s. 2025 dated November 5, 2025 and Bid Bulletin No. 13, s. 2025 dated November 12, 2025 were issued;

WHEREAS, during the bid submission and opening, the BAC received sealed bids, offering the financial bids for **LOT 1** and **LOT 2**, as read:

WHEREAS, using the checklist of required documents and taking into account the non-discretionary "Pass or Fail Criterion", the BAC found the following bidders as compliant with the specifications issued by this office as follows:

WHEREAS, upon post-qualification proceedings and careful examination, validation and verification of all the eligibility, legal, technical, and financial requirements submitted by **FEP PRINTING CORPORATION** as the Single Calculated Bid (SCB) for **LOT 1**, it was found that the *Statement of Ongoing and Awarded Contracts* is **non-responsive** due to the failure to disclose the correct information regarding the signatories of the supporting documents based on the results of the post-qualification evaluation and the verification of the submitted bid;

WHEREAS, Section 52.6 of Republic Act No. 12009 provides that:

"The Procuring Entity can reassess a bidder's qualifications at any stage of the procurement process if there are reasonable grounds to believe that a misrepresentation has been made by the said bidder or if there has been a change in the bidder's capability to undertake the project from the time it submitted its eligibility requirements. If any false information or changes affecting eligibility are found, the bidder shall be disqualified from obtaining an award or implementing the contract, as the case may be, subject to the applicable rules under this IRR.";

WHEREAS, in the Statement of Ongoing and Awarded Contracts, under Column 2 (Owner's Name), the listed projects indicate that **FEP PRINTING CORPORATION** was awarded by the Department of Education under the name of Atty. Michael Wesley T. Poa, Undersecretary and Chief of Staff, Head of the Procuring Entity. However, this appears to be a misrepresentation, as the attached documents were actually signed by Atty. Peter Irving C. Corvera as the Head of the Procuring Entity;

WHEREAS, the discrepancy is material and substantial, as accurate information regarding the signatory is essential in determining the authenticity and validity of the documents submitted;

WHEREAS, upon post-qualification proceedings and careful examination, validation and verification of all the eligibility, legal, technical, and financial requirements submitted by **VECO PAPER CORPORATION** for **LOT 2** as the Single Calculated Bid (SCB), the bid of **VECO PAPER CORPORATION** for **LOT 2** has found to be responsive;

WHEREAS, attached hereto is the post qualification report for **FEP PRINTING CORPORATION** as Annex "A" and **VECO PAPER CORPORATION** as Annex "B" and made an integral part hereof;

WHEREAS, after review and deliberation on the bid and the report, **VECO PAPER CORPORATION** complied with the requirement and is hereby declared as the Single Calculated and Responsive Bid (SCR) for **LOT 2**;

NOW, THEREFORE, the **BAC** hereby **RESOLVES** as it hereby **RESOLVED**:

1. To **DECLARE FEP PRINTING CORPORATION** as ineligible bidder for **ROIVA-2025-12 - LOT 1** due to the failure to disclose the correct information regarding the signatories of the supporting documents.
2. To **DECLARE** the bid of **VECO PAPER CORPORATION** in the amount of **TWENTY MILLION EIGHTY-TWO THOUSAND EIGHT HUNDRED NINETY PESOS AND 24/100 (PHP20,082,890.24)** for **LOT 2** as the Single Calculated and Responsive Bid.
3. To **RECOMMEND** to the Regional Director, as the Head of the Procuring Entity, the award of contract to **VECO PAPER CORPORATION** for the procurement of **Supply and Delivery of Ibong Adarna and Florante At Laura Supplementary Reading for Grade 7 and 8 for SY 2025-2026 with reference number ROIVA-25-12 - LOT 2** in the amount of **TWENTY MILLION EIGHTY-TWO THOUSAND EIGHT HUNDRED NINETY PESOS AND 24/100 (PHP20,082,890.24)**.
