1. To DECLARE the bid of **PETER JOHN ENTERPRISES / LIEL JAY OFFICE AND SCHOOL SUPPLIES TRADING JOINT VENTURE** in the amount of **Twenty-Two Million Three Hundred Eighty Thousand One Hundred Seventy-Nine Pesos and 55/100 (PHP22,380,179.55)** for Lot 1 as the Lowest Calculated and Responsive Bid.
2. To DECLARE **ROMAN INSTRUCTIONAL MEDIA RESOURCES, INC.** as ineligible bidder for failure to submit the required supporting documents in the Statement of the bidder's Single Largest Completed Contract (SLCC).
3. To DECLARE the bid of **BELTRANTAN TRADING** in the amount of **Four Million Three Hundred Forty-Four Thousand Four Hundred Ten Pesos (PHP4,344,410.00)** for LOT 2 and **Two Million Four Hundred Ten Thousand One Hundred Pesos (PHP2,410,100.00)** for LOT 3 as the Lowest Calculated and Responsive Bid.
4. To DECLARE the bid of **RALCO COMMERCIAL TRADING** in the amount of **One Million Eight Hundred Seventy-Seven Thousand Seven Hundred Eighty-Seven Pesos and 7/100 (PHP1,877,787.07)** for Lot 4 as the Lowest Calculated and Responsive Bid.
